In order to comply with the sales tax collection requirements of the State of Colorado CWMA will be adding state and local sales tax collections to all publication orders in the near future. If you are tax-exempt and have already set up an account with CWMA at any time since January, 2011 (for online ordering) you will receive a separate email soon asking for documentation of your sales tax exemption status

(government entities and certain nonprofits). This will allow us to manually modify the system so that sales tax is automatically NOT added to your future orders.
